**Be prepared to set up secure and shaded quarters for your dog(s). You must work on the track when your dogs are not racing. Keep in mind that it takes seven (7) people other than those slipping and catching to run your dog! If you are unable to work on the track, bring someone who can do so.**

From Hwy 50 exit Sunrise Blvd South. Turn left onto Jackson Hwy, turn left at the next signal onto Grantline Rd. Turn left at first stop stop onto Kiefer Blvd., a gravel road - Barron Ranch is on the right, 12435 Keifer Blvd.
